## Long-term plan for research and higher education

World-leading research communities have global impact:

i. They achieve research results that provide completely new insight ii. They train candidates who are sought-after worldwide iii. They create innovations that achieve broad application

- convince politicians to organise economic communities in new ways
- change how we understand the world around us and our presence in it
- develop new technologies that they change the lives of billions of people



# Our inspiration: Research Excellence Framework (UK)



### The research of 154 UK universities was assessed

They made **1,911** submissions including:

- 52,061 academic staff
- **191,150** research outputs ۰
- 6,975 impact case studies •

The overall quality of submissions was judged, on average to be:

- $\star \star \star \star$ 30% world-leading (4\*)
  - 46% internationally excellent (3\*)
  - 20% recognised internationally (2\*)
- 3% recognised nationally (1\*)

# Societal impact (REF definition)

Societal impact is defined as an effect on, change or benefit to: the economy, society, culture, public policy or services, health, the environment or quality of life, beyond academia.

Impact includes, but is not limited to, an effect on, change or benefit to:

- the activity, attitude, awareness, behaviour, capacity, opportunity, performance, policy, practice, process or understanding
- of an audience, beneficiary, community, constituency, organisation or individuals
- in any geographic location whether locally, regionally, nationally or internationally.
- Impact includes the reduction or prevention of harm, risk, cost or other negative effects.
- Academic impacts on research or the advancement of academic knowledge are excluded.
- Impacts on students, teaching or other activities are included.
