

Statement from Evaluation Committee 1 (Higher Education Sector)

This report is from Evaluation Committee 1 which evaluated the following administrative units representing the higher education sector in the Evaluation of Biosciences 2022-2023:

- Faculty of Veterinary Medicine (VET), NMBU
- Department of Biology (IBI), NTNU
- Faculty of Science and Engineering, UiA
- The Department of Natural History, NTNU
- University Museum of Bergen (UM), UiB
- Natural History Museum (NHM), UiO
- The Arctic University Museum of Norway, UiT

The conclusions and recommendations in this report are based on information from the administrative units (self-assessment), digital meetings with representatives from the administrative units, bibliometric analysis and personnel statistics from the Nordic Institute for Studies of Innovation, Research, and Education (NIFU) and Statistics Norway (SSB), and selected data from Studiebarometeret and the National Teacher Survey (Norwegian Agency for Quality Assurance in Education [NOKUT]). The digital interviews took place in Autumn 2023.

This report is the consensus view from committee 1. All members of the committee have agreed with the assessments, conclusions and recommendations presented here.

Profile of the administrative unit

The University Museum of Bergen (UM) has a total of 42 research and 111 technical/administrative staff. The research personnel are comprised of 11 professors, 13 associate professors, one post-doc, nine researchers and eight PhD-students. Women represent a minority of all types of research personnel except post-docs for which the only one is a woman.

The University Museum of Bergen is comprised of one research group in biology, Biosystematics & Paleobiology (UMBIO).

The University Museum aims to be recognised as a leading museum based on basic research within cultural and natural history, and collections, exhibitions, and outreach activity of high international quality. UMBIO specifically strives to be nationally leading in marine biosystematics and in paleobiology. An interdisciplinary perspective on research is encouraged with collaboration between palaeobiology and archaeology. The university museum has regional responsibility for management in relation to the Law of Cultural Heritage, which implies collection of scientific soil samples and bone material by UMBIO. According to the University Museum, the organisation of collection management as a separate unit with dedicated responsibility for the whole museum, maximises synergies in updated management procedures and collection security. The museum mentions that it is important with communication of research through museum exhibitions focusing on processes to increase the public awareness of research-based knowledge. UMBIO has been involved in development of new exhibitions at the museum, opened in 2019 and honoured as the Norwegian Museum of the year in 2021 and the European Museum Award “The Portimão Museum Prize for welcoming, inclusion and belonging” in 2022.

As a higher education institution, the University Museum strives to reach the four overall goals of Norwegian Higher Education Institutions. In relation to these goals, the administrative unit mentions that the collections represent the core of the activity; the administrative unit's staff describe, identify, document and report on existing species and objects, and thereby obtain data that make the basis for its research. The administrative unit also has sector-specific objectives towards public administration such as knowledge of existing species needed in relation to nature conservation and management, in which they contribute through projects from the Norwegian Biodiversity Information Centre (NBIC) and in the collaboration with the Institute of Marine Research (IMR). The University Museum is the core repository of material collected in the MAREANO endeavour, the EAF Nansen project of FAO, and in Antarctic surveys conducted by the Norwegian Polar Institute. A reference collection for the bulk of DNA-barcoded marine animals in Norway is developed.

Based on its self-assessment, the University Museum in the future might take advantage of it having both natural and cultural scientific fields within one administrative unit, that encourages interdisciplinary research which is increasingly important to answer societal challenges and understand processes forming our natural and cultural history. Collaboration with other university museums in relation to the shared scientific Collection Management System might lead to further development of the collections as an important national research infrastructure, international visibility, and national and international research collaboration.

Overall assessment

Research at the University Museum (UM) has its basis in the scientific collections. The museum spans natural and cultural history and has the potential to increase interdisciplinary research in these areas. The department of natural history focuses on three areas: evolutionary history and taxonomy of species, paleobiology and geology.

Within UMBIO there is an inverted pyramid of staff, with 5 Professors, 8 Associate professors and only 1 Postdoc and 4 PhD students. The overall assessment considering the Terms of Reference provided by the administrative unit is that the overall strategy and quality of research is good. It would be valuable to increase the proportion of PhD and early career researchers relative to faculty, however. Most of the total budget is core funding from the Ministry of Education and Research. There is scope to increase the amount of competitive external funding. The University Museum (UM) has a substantive research output but needs to find external sources of funding as it is significantly reliant on fixed allocation from the Ministry. The activities of UM and UMBIO are making an important societal contribution in the areas of conservation management of nature and cultural heritage. UM also has a key focus as a hub for knowledge sharing and public engagement, leading to national and international recognition with awards such as the Norwegian Museum of the Year Award 2021 and the European Museum of the Year Award 2022. Visitor engagement through exhibitions, events, and school programs has markedly increased, reflecting the societal significance of the museum's initiatives. Importantly the public exhibitions are based on the Museum's research activities.

Recommendations

The evaluation committee recommends to:

- Further develop strategies for collection and digitisation alongside research.
- Further develop opportunities for interdisciplinary research in the natural and cultural scientific fields.
- Consider approaches that will allow an increase in the number of early career researchers (PhDs and Post-docs)
- Consider options for increasing the amount of competitive external funding applied for by the administrative unit.
- Increase the number and proportion of open access publications.
- The activities of UM in conservation management of nature and cultural heritage are making a contribution to many of the UN Sustainable Development Goals, it would be beneficial to articulate these further.

1. Strategy, resources and organisation of research

The University Museum (UM) research is grounded in extensive scientific collections, bridging natural and cultural history, and is dedicated to interdisciplinary studies with a focus on Western Norway. Its Natural History department emphasises evolutionary taxonomy, paleobiology, and geology, while Cultural History adopts human-centered approaches to landscape interactions. A hallmark of UM is its collections-based research and public engagement through museum exhibitions. The overall research strategy is good and appropriate for a museum.

UM's funding predominantly comes from core government support, with a need to diversify and increase competitive external funding, currently a minor portion of its budget. UMBIO, a department within UM, benefits from diverse collection access and modern laboratories, supported by the University of Bergen and various external facilities. Participation in national and international biodiversity networks like NorBOL and GBIF underscores UM's commitment to global data sharing.

UMBIO shows a skewed structure with more senior staff compared to early career researchers, intending to produce one PhD graduate annually. There is some tension arising from the necessity for broad in-house expertise for the collections against the backdrop of conducting high impact research. External collaborations and sabbaticals inject dynamism into the group.

1.1 Research Strategy

The University Museum has limited resources to act strategically due to reduced funding to UM over the past years. UM lacks scientific staff to develop strategic approaches to new areas in collection-based research, such as exploring the use of new molecular techniques in collections. The research at the University Museum has its basis in the scientific collections and forms the foundation for all the museum's other activities. Research is globally oriented, but with a particular responsibility for Western Norway. The museum spans natural and cultural history, which provides an opportunity to cross the traditional boundaries between the two disciplines. The focus on collections-based research is very good and an important aspect of museum-based research.

The department of natural history focuses on three areas: evolutionary history and taxonomy of species, paleobiology and geology. The department of cultural history focuses on 'perspectives from below' and 'man and the landscape (Note: we advise the use of non-gendered terminology here – i.e. humans and the landscape). Interdisciplinarity of research is emphasised, as well as the importance of outreach activities – with the communication of research in new exhibitions in the museum described in detail.

UM sees its strength in collections-based research, which is an appropriate and important contribution that all natural history museums can make. It also emphasises interdisciplinarity and outreach. It has focused on ensuring staff cover the full taxonomic range of the collections and states that this makes it more difficult to be a scientifically strong research community within one field. This approach is considered a threat to the future development of UM and the competitiveness for external funding to support research.

1.2 Organisation of research

Research at UM takes place at the Department of Natural History and Department of Cultural History. The Heads of the department act as leaders for the research and are responsible for following up strategic goals. The organisation is rather top-heavy and could benefit from more PhD and early-career researchers. There are also research coordinators within the respective departments and at lower organisational levels, research is centred around the different types of scientific collections, or in the form of specific research projects. The maintenance of collections infrastructure has a high cost which could potentially limit other activities within the museum.

1.3 Research funding

There is scope to increase the amount of competitive external funding. Currently, 80% of the total budget of the administrative unit is core funding from the Ministry of Education and Research. The administrative unit has a substantive research output but as it is significantly reliant on fixed allocation from the Ministry, it is important to find external sources of funding. Competitive funding in 2021 amounted to only 16% of external funding or 5% of total activity and included MEDUSA, a project with Russia.

Many projects that were listed in the administrative unit's self-assessment have ended, with limited future funding from the three ongoing ones. A strategy for increasing external funding is required to create a pipeline of projects going forward. UMBIO receives a fixed allocation from the Ministry via UiB, which earmarks funding for collection management and PhD studentships. External funding for UMBIO is one third of the group's total budget, of which the Norwegian Biodiversity Information Centre and the Institute of Marine Research are the most significant. Funding for palaeobiology is limited, with archaeological projects being the major contributor. Their interactions with the Institute for Marine Research and Polar Institute, Norwegian Biodiversity Information Center, and Norwegian Barcode of Life make them an attractive research partner but despite this neither EU nor RCN are major sources of funding. We suggest investigating how funding can be increased from these sources.

1.4 Use of infrastructures

UMBIO is part of NorBOL (Norwegian Barcode of Life Network), which is a network within the University Museums in Norway for collaboration on DNA barcoding and participates in the Norwegian Node of GBIF. It is also part of MUSIT, the digitisation initiative for university museums in Norway. It is part of the DiSSCo initiative. These are all appropriate infrastructures for the administrative unit to be part of and demonstrate that it is working well in this area. UM states that it adheres to FAIR principles, but it is not stated specifically how it achieves this.

A strength of UMBIO is the range and variety of access to collections infrastructure, however, with this comes considerable fixed costs. Internally, in addition to the collections and botanic garden, they have a molecular (for degraded DNA) and palynological lab. UiB provides resources for collections management and storage, Estates and Facilities management, IT infrastructure, isotopes, libraries, Espeland marine station, UIB/IMR research vessels and associated infrastructure and PhD students. Externally, UMBIO have access to other natural

history collections and biodiversity databases, E-infrastructures, marine stations, and the 14C facility at NTNU.

1.5 National and international collaboration

The national and international collaboration network of the administrative unit is good and appropriate for a museum of this size. UMBIO takes part in the national research infrastructure NorBOL (Norwegian Barcode of Life Network). NorBOL is also a regional node in the International Barcode of Life Project. NTNU, University Museum has been the host institution for this national network. UMBIO also participates in the Norwegian Node of the Global Biodiversity Facility (GBiF), which is an infrastructure for biodiversity data. UMBIO submits data and thereby contributes to the development of the infrastructure. Other existing national infrastructures mentioned in the Norwegian roadmap are MUSIT (the IT-organisation of the University Museums) now developed into UniMus:kultur for collections within cultural history, and Digitaltmuseum.no. The MUSIT databases in natural history are still in use, but this will be replaced by a new national collaboration on Collection Management System, NOR-CMS.

UM is part of The Distributed System of Scientific Collections (DiSSCo) consortium in Norway, which includes all Norwegian University Museums. DiSSCo is a distributed research infrastructure aiming to integrate European natural science collections for data-intensive research and innovation in environment, food security, health, and bioeconomy. It aims to digitally unify all European natural science assets under common access and common curation policies, ensuring that the FAIR principles are applied to natural history data.

1.6 Research staff

A tension is evident between the needs of the museum to have in house competence on a variety of organismal groups and types of collections but with a limited number of positions. Research personnel at UM overall consists of 42 people; 11 professors, 13 assistant professors, one post doc, nine researchers, and eight PhD students. The overall number of faculty is appropriate, for a museum of this size, but the number of early career researchers (post-doc and PhD) is lower than expected. In addition to the scientific positions, UM has technical/administrative staff closely connected to the research. This includes research-based laboratory activities, projects in relation to Cultural Heritage Law including sampling and analysis of biological data, projects funded by the Norwegian Biodiversity Information Centre, and by the Institute of Marine Research. Within collection management, conservation, and research communication, some of the employees are strongly connected to research without being included in the numbers reported. Administrative support includes six administrative employees serving the entire University Museum (in total 227). The Museum Director/Dean is a professor, but not included in the numbers.

UM has an acceptable balance of females and males in research positions, although should work to increase the proportion of female professors. There are 11 professors, but only 27% female. Associate professors are 46% female and researchers 44% female. The number of post-docs (1) and PhDs (8) are lower than the number of professors and associate professors.

Within UMBIO there is an inverted pyramid of staff, with 5 Professors, 8 Associate professors (mostly from outside Norway), and only 1 Postdoc and 4 PhD students - teaching is encouraged but not mandatory, and the group aims to produce one PhD graduate each year. The group is refreshed by UIB sabbaticals and many visiting researchers and students.

2. Research production, quality and integrity

Overall, research production, quality and integrity is good but more external funding needs to be brought in to develop this more. It is positive to see that open science is aligned with UiB policy but further work is needed in this area to increase the proportion of open access publications. Research at UMBIO is important due to demand for taxonomic skills, interest in biological collections as molecular archives and increasing accessibility of collections via digitisation. UMBIO has good facilities, but these come with high fixed costs and curatorial responsibilities which restrict their ability to manoeuvre. A challenge for UMBIO is the need to fulfil its responsibilities for collections management and meet increasing demands for access as well as increase its research potential. To do this it will need to raise a higher proportion of external funding. UM states that open access is important, and the University of Bergen offers training in Open Science for UMs researchers. In 2021 62% of publications were open access but it is not stated if this has increased or decreased and what strategies will be used to increase open access across all areas in the future.

2.1 Research quality and integrity

UMBIO is a large heterogeneous marine and paleobiology focused research group at a small museum. UMBIO is internationally facing, most of the scientific staff are from outside Norway. It has a special role in knowledge transfer to the public through its Natural History Museum, botanic gardens, marine projects, science festivals, and active engagement with various biological societies. The research space occupied by UMBIO is active due to (i) demand for taxonomic skills (ii) interest in biological collections as molecular archives (iii) increasing accessibility of collections via digitisation (iv) new methods for biodiversity monitoring, such as eDNA and sedDNA. UMBIO has good facilities, but these come with high fixed costs and curatorial responsibilities which restrict their ability to manoeuvre. A challenge for UMBIO is the need to fulfil its responsibilities for collections management and meet increasing demands for access as well as increase its research potential. To do this it will need to raise a higher proportion of external funding.

2.2. Open Science

UM follows the UiB policy for open science, where openness, transparency and knowledge exchange are core values, however the number of open access publications is lower than expected and plans should be put in place to increase this proportion in the future. It is based on the principle that research and research processes are to be “as open as possible and as closed as necessary”. The policy covers open access to research publications, open access to research data, open innovation, open educational resources, and citizen science. The goal

of UiB and UM is that data resulting from research activities should be made readily available for reuse in accordance with FAIR-principles. Researchers are encouraged to make their data openly available as early as possible in the research process. UIB offers training in Open Science for UMs researchers. In 2021 62% of publications were open access but it is not stated if this has increased or decreased and what strategies will be used to increase open access across all areas in the future.

3. Diversity and equality

UM follows the University of Bergen's Diversity and Inclusion Action Plan and the Gender Equality Action Plan which are actively engaged in promoting equality and diversity. It is a goal that no-one shall experience discrimination based on gender, ethnicity, national origin, language, religion and beliefs, functional abilities, sexual orientation, gender identity or age. Work on equality, diversity and inclusion shall be clearly incorporated at all levels of management. UM also follows the UiB ethical guidelines for relations between supervisors and students or candidates. As part of the systematic HSE work at the museum, all employees are each year informed about UIBs guidelines on whistleblowing.

4. Relevance to institutional and sectorial purposes

UM has a specific focus on nature conservation and its management and cultural heritage management. Commercialisation is not part of the museum's strategy. The relevance to institutional and sectorial purposes is high and the administrative unit is performing well in this area. The collections distinguish UMBIO as an important research environment, with a focus on marine groups, paleobiology, and archaeology. In biosystematics, UMBIO produces alpha level information essential for associated biological disciplines and curates collections. In paleobiology UMBIO works closely with archaeologists, participating in excavations and work on contract archaeology.

UMBIO's expertise in marine and paleobiology aligns with UM and UIB's strategies. In building and improving scientific collections, they both contribute to UM's core values, and provide services to researchers worldwide.

UMBIO provides training for junior researchers both internally and externally. UMBIO organises a seminar series and offers both external training as well as ad hoc internal provision to meet specific needs. External training is typically from graduate level and one UMBIO Assistant Professor dedicates 25% of her time to coordinate ForBio.

Research-based outreach is a central activity, with researchers contributing to museum exhibitions at the University Museum in Bergen.

5. Relevance to society

UMBIO contribution to economic, societal and/or cultural development in Norway and/or internationally is considerable given what is expected from groups in the same research field. This is well demonstrated by the two impact case studies. Their contributions to the public sector include work for the Norwegian Biodiversity Center, such as the development of red and blacklists. UMBIO provides reference collections for non-academic institutes,

conservation biologists and nature managers. They contribute to seed banks and botanic gardens for conservation and advise on conservation, ecosystem restoration, sustainable land-use and preservation of cultural heritage. Most listed reports arise from contracts with external institutions and stakeholders.

Societal partners have considerable involvement in the research process, from problem formulation to the publication and/or process of product innovation. UMBIO works with volunteers in the “Friends of the Arboretum” and citizen science projects and provides training for private monitoring companies. It won the “Portimão Museum Prize for welcoming, inclusion and belonging” in 2022 for their contribution to society.

UMBIO’s work has led to the creation of innovative products such as regional seed mixes for meadows and green roofs for food production, as well as web-based keys for selected Norwegian fauna. The group’s work has significant implications for achieving ecological stability and ultimately health and economic stability for humans.

Comments to impact case 1 - The impact of collection-based marine biodiversity studies

This is an excellent impact case study which demonstrates a high level of societal impact. Research at the University Museum (UM) focuses on taxonomy, systematics, and evolution, using the comprehensive scientific collections acquired through species inventories. The research has led to biological insights with far-reaching impacts beyond academia, particularly in DNA barcoding which has been instrumental in ecosystem management and monitoring, as well as in policymaking.

This is illustrated by the research within marine biodiversity which focuses on taxonomy, systematics, and animal evolution. The museum’s active collection work in this area has attracted guest researchers globally, with significant academic publications resulting from access to these collections. Collaborations with various research institutes and projects, like the MAREANO project and EAF Nansen program, have turned the museum into a key repository for marine samples, contributing to the international “Barcode of Life” initiative and the BOLD database.

UM’s work has been crucial in establishing a reference collection of DNA-barcoded marine animals in Norway. The partnership with the National Institute of Marine Research (IMR) and the Norwegian Polar Institute has yielded significant scientific advances. The museum’s contributions have also supported important decisions regarding environmental monitoring and marine mining policies.

The museum’s extensive participation in the Norwegian Biodiversity Information Centre (NBIC) species inventories highlights its role in citizen science and knowledge dissemination. The involvement in Red List committees and taxonomic databases, as well as its role in advocating for Marine Protected Areas, illustrates the breadth of the museum’s impact. Social outreach through media, popular publications, and educational events extends the museum’s influence further into public engagement and conservation efforts.

Finally, the Research School in Biosystematics (ForBio), coordinated by UM, evidences the institution’s dedication to educating the next generation of biosystematists, crucial for biodiversity expertise and environmental management.

Comments to impact case 2 - Research Based Exhibitions at Muséplassen 3

This is an excellent impact case study which illustrates the importance of public engagement within museums and the important societal impact that this can have. The renovation of Norway's oldest museum building (Muséplassen 3) involved preserving the historical essence of the building while integrating it with contemporary museum functionalities. This transformation allowed for a dual impact: maintaining the building's architectural integrity and showcasing high-quality, research-based exhibitions. The renovation spanned from 2016 to 2019, with a goal to highlight ongoing museum-based research through 19 new exhibitions, doubling the visitor count since reopening.

The impact study highlights five exhibitions, including "The Unknown Land" which showcases deep-sea biodiversity and new species discovery, and "The Whale Hall," presenting research on marine life and plastic pollution. The "Plants – Classification and Strawberries" exhibition brings botany to life using strawberries, and "Birds – The Dinosaurs Amongst Us" connects avian migration research to broader ecological understanding. Lastly, "Pollen and Bone" merges disciplines to narrate environmental and anthropogenic changes over time.

Details of the impact are multifaceted. The museum's new role as a hub for knowledge sharing and public engagement has been profound, leading to national and international recognition with awards such as the Norwegian Museum of the Year Award 2021 and the European Museum of the Year Award 2022. The museum serves as a platform for democratizing knowledge, fostering public trust in research, and encouraging future generations toward scientific careers. Visitor engagement through exhibitions, events, and school programs has markedly increased, reflecting the societal significance of the museum's initiatives. The University Museum at Bergen has successfully reframed itself as a modern centre of learning, inclusivity, and community engagement, inspiring other institutions by its example.

Methods and limitations

Methods

The evaluation is based on documentary evidence and online interviews with the representatives of Administrative Unit.

The documentary inputs to the evaluation were:

- Evaluation Protocol Evaluation of life sciences in Norway 2022-2023
- Administrative Unit's Terms of Reference
- Administrative Unit's self-assessment report
- Administrative Unit's impact cases
- Administrative Unit's research groups evaluation reports
- Panel reports from the Expert panels
- Bibliometric data (*NIFU Nordic Institute for Studies of innovation, research and education*)
- Personnel data (*Statistics Norway (SSB)*)
- Funding data – The Research Council's contribution to biosciences research (*RCN*)
- Extract from the Survey for academic staff and the Student Survey (*Norwegian Agency for Quality Assurance in Education (NOKUT)*)

After the documentary review, the Committee held a meeting and discussed an initial assessment against the assessment criteria and defined questions for the interview with the Administrative Unit. The Committee shared the interview questions with the Administrative Unit two weeks before the interview.

Following the documentary review, the Committee interviewed the Administrative Unit in an hour-long virtual meeting to fact-check the Committee's understanding and refine perceptions. The Administrative Unit presented answers to the Committee's questions and addressed other follow-up questions.

After the online interview, the Committee attended the final meeting to review the initial assessment in light of the interview and make any final adjustments.

A one-page summary of the Administrative Unit was developed based on the information from the self-assessment, the research group assessment, and the interview. The Administrative Unit had the opportunity to fact-check this summary. The Administrative Unit approved the summary without adjustments. The Committee judged the information received through documentary inputs and the interview with the Administrative Unit sufficient to complete the evaluation.

The Committee judged that the Administrative Unit self-assessment report was insufficient to assess all evaluation criteria fully. However, the interview with the Administrative Unit filled gaps in the Committee's understanding, and the information was sufficient to complete the evaluation.


By evaluating Norwegian research and higher education we aim to enhance the quality, relevance, and efficiency. In accordance with the statutes of the Research Council of Norway (RCN), the RCN evaluates Norwegian professional environments to create a solid and up-to-date knowledge base about Norwegian research and higher education in an international perspective.

The evaluation of life sciences is conducted in 2022 - 2024. The evaluation of biosciences takes place in 2022 - 2023, and the evaluation of medicine and health is carried out in 2023-2024. The primary aim of the evaluation of life sciences is to reveal and confirm the quality and the relevance of research performed at Norwegian Higher Education Institutions (HEIs), the institute sector and the health trusts. The evaluation shall result in recommendations to the institutions, the RCN and the ministries.

Evaluation of biosciences (EVALBIOVIT) 2022-2023

The evaluation of biosciences includes twenty-two administrative units (e.g., faculty, department, institution) which are assessed by evaluation committees according to sectorial affiliation and/or other relevant similarities between the units. The administrative units enrolled their research groups (97) to five expert panels organised by research subjects or themes and assessed across institutions and sectors.

Organisation of evaluation of biosciences research 2022 - 2023



The institutions have been allowed to adapt the evaluation mandate (Terms of Reference) to their own strategic goals. This is to ensure that the results of the evaluation will be useful for the institution's own strategic development. The administrative unit together with the research group(s) selects an appropriate benchmark for each of the research group(s).

The Research Council of Norway has commissioned an external evaluation secretariat at Technopolis Group for the implementation of the evaluation process.

Each institution/administrative unit is responsible for following up the recommendations that apply to their own institution/administrative unit. The Research Council will use the results from the evaluation in the development of funding instruments and as a basis for advice to the Government.

Fagevaluering av biovitenskap (EVALBIOVIT) 2022 – 2023

Vi viser til invitasjonsbrev om å delta i fagevaluering av biovitenskap (EVALBIOVIT) datert 11.11.2021 og til informasjonsmøte med innmeldte administrative enheter 15.12.2021.

Porteføljestyret for livsvitenskap vedtok evalueringsprotokollen for fagevaluering av biovitenskap 05.04.2022 (vedlegg 1). Protokollen beskriver roller, prosesser og ansvarsfordeling i evalueringsarbeidet og er i tråd med forslaget til nytt nasjonalt rammeverk for evaluering av forskning og høyere utdanning utarbeidet i regi av Kunnskapsdepartementet.

Forskningsrådet har mottatt innmelding av 37 administrative enheter til EVALBIOVIT. Disse vil bli fordelt på sektorspesifikke evalueringskomitéer: 1-2 evalueringskomité/er for administrative enheter som tilhører instituttsektoren og 1-2 evalueringskomité/er for administrative enheter som tilhører UH-sektor. Universitetsmuseene vil bli evaluert samlet i én evalueringskomité for UH-sektor. Det skal i tillegg opprettes internasjonale fagekspertpaneler etter faglig eller tematisk likhet på tvers av sektorer. Ekspertpanelene skal evaluere forskergruppene som de administrative enhetene melder inn. Evalueringskomitéene og ekspertpanelene skal vurdere de innsamlede dataene og gi anbefalinger til den enkelte institusjon, til Forskningsrådet og til departementene.

Tilpasning av mandat (vedlegg 1)

Forskningsrådet ber med dette administrative enheter om å tilpasse mandatet (vedlegg 1) til de lokale forhold ved egen institusjon. Tilpasningen gjøres ved å fylle inn de åpne punktene i malen (Appendix A). Utfylt skjema sendes på epost til evalbiovit@forskningsradet.no innen 30. september 2022.

Innmelding av forskergrupper (vedlegg 2a og 2b)

Forskningsrådet ber administrative enheter om å melde inn forskergrupper i tråd med forskergruppedefinisjonen beskrevet i kapittel 1.2 i evalueringsprotokollen. Det bes også om at forskergruppene innplasseres i den tentative fagpanelinndelingen for EVALBIOVIT (vedlegg 2a). Utfylt regneark (vedlegg 2b) sendes til evalbiovit@forskningsradet.no innen 31. mai 2022.

Forskningsrådet vil ferdigstille panelstruktur og avgjøre den endelige fordelingen av forskergruppene på fagpaneler etter at alle forskergrupper er meldt inn.

Invitasjon til å foreslå eksperter (vedlegg 3a og 3b)

Forskningsrådet inviterer administrative enheter til å spille inn forslag til eksperter som kan inngå i evalueringskomitéene og i ekspertpanelene (vedlegg 3a). Hver evalueringskomité skal bestå av 7-9 komitémedlemmer. Hvert ekspertpanel skal bestå av 5-7 eksperter. Utfylt regneark (vedlegg 3b, fane 1 og fane 2) sendes til evalbiovit@forskningsradet.no innen 31. mai 2022.

Forskningsrådet v/porteføljestyret for livsvitenskap vil oppnevne leder og medlemmer til evalueringskomitéene og til ekspertpanelene.

Data og datainnsamling

Forskningsrådet har nå ute et oppdrag for analyse av data om personal og forskningsproduksjon. Analysen skal i hovedsak baseres på data i DBH, NIFUs forskerpersonaleregister og Cristin. Analysene vil inkludere indikatorer som skal brukes for evaluering av alle institusjoner.

Videre vil institusjonene få et ansvar for innsamling av data til en egevaluering som skal inngå i vurderingsgrunnlaget for evalueringskomiteene. For å sikre at evalueringen blir nyttig for forskningsinstitusjonenes utvikling, vil Forskningsrådet også invitere institusjonene til å delta i utvelgelse av relevante evalueringsdata og indikatorer som kan danne grunnlag for vurdering opp mot institusjonens egne strategiske mål og sektormål. På bakgrunn av dette har Forskningsrådet en forventning om at institusjonene som deltar i evalueringen stiller med nødvendige ressurser gjennom hele evalueringsprosessen.

Forskningsrådet har, etter en anbudskonkurranse om sekretariatstjenester, inngått en avtale med Technopolis Group som skal bistå Forskningsrådets administrasjon i arbeidet med EVALBIOVIT. Sekretariatet skal blant annet koordinere datainnsamlingen fra institusjonene og systematisere det innsamlede materialet for vurdering i ekspertpaneler og evalueringskomitéer.

Endring av administrativ enhet

For noen få tilfeller kan det være behov for å gjøre noen endringer i forhold til den administrative enheten¹ som allerede er innmeldt til EVALBIOVIT. For eksempel kan et fakultet som ble meldt inn samlet til EVALBIOVIT i desember 2021 finne det mer hensiktsmessig å heller melde inn fakultetets institutter som egne administrative enheter. Hvis man ønsker å endre på den administrative enheten må dette meldes Forskningsrådets administrasjon så fort som mulig, men ikke senere enn 31.05.2022. 1 Introduction

Research assessments based on this protocol serve different aims and have different target groups. The primary aim of the evaluation of life sciences is to reveal and confirm the quality and the relevance of research performed at Norwegian Higher Education Institutions (HEIs), and by the institute sector and regional health authorities and health trusts. These institutions will hereafter be collectively referred to as Research Performing Organisations (RPOs). The assessments should serve a formative purpose by contributing to the development of research quality and relevance at these institutions and at the national level.

1.1 Evaluation units

The assessment will comprise a number of *administrative units* submitted for evaluation by the host institution. By assessing these administrative units in light of the goals and strategies set for them by their host institution, it will be possible to learn more about how public funding is used at the institution(s) to facilitate high-quality research and how this research contributes to society. The administrative units will be assessed by evaluation committees according to sectoral affiliation and/or other relevant similarities between the units.

The administrative units will be invited to submit data on their *research groups* to be assessed by expert panels organised by research subject or theme. See Chapter 3 for details on organisation.

<i>Administrative unit</i>	An administrative unit is any part of an RPO that is recognised as a formal (administrative) unit of that RPO, with a designated budget, strategic goals and dedicated management. It may, for instance, be a university faculty or department, a department of an independent research institute or a hospital.
<i>Research group</i>	Designates groups of researchers within the administrative units that fulfil the minimum requirements set out in section 1.2. Research groups are identified and submitted for evaluation by the administrative unit, which may decide to consider itself a single research group.

1.2 Minimum requirements for research groups

- 1) The research group must be sufficiently large in size, i.e. at least five persons in full-time positions with research obligations. This merely indicates the minimum number, and larger units are preferable. In exceptional cases, the minimum number may include PhD students, postdoctoral fellows and/or non-tenured researchers. *In all cases, a research group must include at least three full-time tenured staff.* Adjunct professors, technical staff and other relevant personnel may be listed as group members but may not be included in the minimum number.

- 2) The research group subject to assessment must have been established for at least three years. Groups of more recent date may be accepted if they have come into existence as a consequence of major organisational changes within their host institution.
- 3) The research group should be known as such both within and outside the institution (e.g. have a separate website). It should be able to document common activities and results in the form of co-publications, research databases and infrastructure, software, or shared responsibilities for delivering education, health services or research-based solutions to designated markets.
- 4) In its self-assessment, the administrative unit should propose a suitable benchmark for the research group. The benchmark will be considered by the expert panels as a reference in their assessment of the performance of the group. The benchmark can be grounded in both academic and extra-academic standards and targets, depending on the purpose of the group and its host institution.

1.3 The evaluation in a nutshell

The assessment concerns:

- research that the administrative unit and its research groups have conducted in the previous 10 years
- the research strategy that the administrative units under evaluation intend to pursue going forward
- the capacity and quality of research in life sciences at the national level

The Research Council of Norway (RCN) will:

- provide a template for the Terms of Reference¹ for the assessment of RPOs and a national-level assessment in life sciences
- appoint members to evaluation committees and expert panels
- provide secretarial services
- commission reports on research personnel and publications based on data in national registries
- take responsibility for following up assessments and recommendations at the national level.

RPOs conducting research in life sciences are expected to take part in the evaluation. The board of each RPO under evaluation is responsible for tailoring the assessment to its own strategies and specific needs and for following them up within their own institution. Each participating RPO will carry out the following steps:

- 1) Identify the administrative unit(s) to be included as the main unit(s) of assessment
- 2) Specify the Terms of Reference by including information on specific tasks and/or strategic goals of relevance to the administrative unit(s)

¹ The terms of reference (ToR) document defines all aspects of how the evaluation committees and expert panels will conduct the [research area] evaluation. It defines the objectives and the scope of the evaluation, outlines the responsibilities of the involved parties, and provides a description of the resources available to carry out the evaluation.

- 3) The administrative unit will, in turn, be invited to register a set of research groups that fulfil the minimum criteria specified above (see section 1.2). The administrative unit may decide to consider itself a single research group.
- 4) For each research group, the administrative unit should select an appropriate benchmark in consultation with the group in question. This benchmark can be a reference to an academic level of performance or to the group's contributions to other institutional or sectoral purposes (see section 2.4). The benchmark will be used as a reference in the assessment of the unit by the expert panel.
- 5) The administrative units subject to assessment must provide information about each of their research groups, and about the administrative unit as a whole, by preparing self-assessments and by providing additional documentation in support of the self-assessment.

1.4 Target groups

- Administrative units represented by institutional management and boards
- Research groups represented by researchers and research group leaders
- Research funders
- Government

The evaluation will result in recommendations to the institutions, the RCN and the ministries. The results of the evaluation will also be disseminated for the benefit of potential students, users of research and society at large.

This protocol is intended for all participants in the evaluation. It provides the information required to organise and carry out the research assessments. Questions about the interpretation or implementation of the protocol should be addressed to the RCN.

2 Assessment criteria

The administrative units are to be assessed on the basis of five assessment criteria. The five criteria are applied in accordance with international standards. Finally, the evaluation committee passes judgement on the administrative units as a whole in qualitative terms. In this overall assessment, the committee should relate the assessment of the specific tasks to the strategic goals that the administrative unit has set for itself in the Terms of Reference.

When assessing administrative units, the committees will build on a separate assessment by expert panels of the research groups within the administrative units. See Chapter 3 'Evaluation process and organisation' for a description of the division of tasks.

2.1 Strategy, resources and organisation

The evaluation committee assesses the framework conditions for research in terms of funding, personnel, recruitment and research infrastructure in relation to the strategic aims set for the administrative unit. The administrative unit should address at least the following five specific aspects in its self-assessment: 1) funding sources, 2) national and international cooperation, 3) cross-sector and interdisciplinary cooperation, 4) research careers and mobility, and 5) Open Science. These five aspects relate to how the unit organises and actually performs its research, its composition in terms of leadership and personnel, and how the unit is run on a day-to-day basis.

To contribute to understanding what the administrative unit can or should change to improve its ability to perform, the evaluation committee is invited to focus on factors that may affect performance.

Further, the evaluation committee assesses the extent to which the administrative unit's goals for the future remain scientifically and societally relevant. It is also assessed whether its aims and strategy, as well as the foresight of its leadership and its overall management, are optimal in relation to attaining these goals. Finally, it is assessed whether the plans and resources are adequate to implement this strategy.

2.2 Research production, quality and integrity

The evaluation committee assesses the profile and quality of the administrative unit's research and the contribution the research makes to the body of scholarly knowledge and the knowledge base for other relevant sectors of society. The committee also assesses the scale of the unit's research results (scholarly publications, research infrastructure developed by the unit, and other contributions to the field) and its contribution to Open Science (early knowledge and sharing of data and other relevant digital objects, as well as science communication and collaboration with societal partners, where appropriate).

The evaluation committee considers the administrative unit's policy for research integrity and how violations of such integrity are prevented. It is interested in how the unit deals with research data, data management, confidentiality (GDPR) and integrity, and the extent to which independent and critical pursuit of research is made possible within the unit. Research integrity relates to both the scientific integrity of conducted research and the professional integrity of researchers.

2.3 Diversity and equality

The evaluation committee considers the diversity of the administrative unit, including gender equality. The presence of differences can be a powerful incentive for creativity and talent development in a diverse administrative unit. Diversity is not an end in itself in that regard, but a tool for bringing together different perspectives and opinions.

The evaluation committee considers the strategy and practices of the administrative unit to prevent discrimination on the grounds of gender, age, disability, ethnicity, religion, sexual orientation or other personal characteristics.

2.4 Relevance to institutional and sectoral purposes

The evaluation committee compares the relevance of the administrative unit's activities and results to the specific aspects detailed in the Terms of Reference for each institution and to the relevant sectoral goals (see below).

Higher Education Institutions

There are 36 Higher Education Institutions in Norway that receive public funding from the Ministry for Education and Research. Twenty-one of the 36 institutions are owned by the ministry, whereas the last 15 are privately owned. The HEIs are regulated under the Act relating to universities and university colleges of 1 August 2005.

The purposes of Norwegian HEIs are defined as follows in the Act relating to universities and university colleges²

- provide higher education at a high international level;
- conduct research and academic and artistic development work at a high international level;
- disseminate knowledge of the institution's activities and promote an understanding of the principle of academic freedom and application of scientific and artistic methods and results in the teaching of students, in the institution's own general activity as well as in public administration, in cultural life and in business and industry.

In line with these purposes, the Ministry for Research and Education has defined four overall goals for HEIs that receive public funding. These goals have been applied since 2015:

- 1) High quality in research and education
- 2) Research and education for welfare, value creation and innovation
- 3) Access to education (esp. capacity in health and teacher education)
- 4) Efficiency, diversity and solidity of the higher education sector and research system

The committee is invited to assess to what extent the research activities and results of each administrative unit have contributed to sectoral purposes as defined above. In particular, the committee is invited to take the share of resources spent on education at the administrative units into account and to assess the relevance and contributions of research to education, focusing on the master's and PhD levels. This assessment should be distinguished from an

assessment of the quality of education in itself, and it is limited to the role of research in fostering high-quality education.

Research institutes (the institute sector)

Norway's large institute sector reflects a practical orientation of state R&D funding that has long historical roots. The Government's strategy for the institute sector³ applies to the 33 independent research institutes that receive public basic funding through the RCN, in addition to 12 institutes outside the public basic funding system.

The institute sector plays an important and specific role in attaining the overall goal of the national research system, i.e. to increase competitiveness and innovation power to address major societal challenges. The research institutes' contributions to achieving these objectives should therefore form the basis for the evaluation. The main purpose of the sector is to conduct independent applied research for present and future use in the private and public sector. However, some institutes primarily focus on developing a research platform for public policy decisions, others on fulfilling their public responsibilities.

The institutes should:

- maintain a sound academic level, documented through scientific publications in recognised journals
- obtain competitive national and/or international research funding grants
- conduct contract research for private and/or public clients
- demonstrate robustness by having a reasonable number of researchers allocated to each research field

The committee is invited to assess the extent to which the research activities and results of each administrative unit contribute to sectoral purposes and overall goals as defined above. In particular, the committee is invited to assess the level of collaboration between the administrative unit(s) and partners in their own or other sectors.

The hospital sector

There are four regional health authorities (RHF) in Norway. They are responsible for the specialist health service in their respective regions. The RHF are regulated through the Health Enterprises Act of 15 June 2001 and are bound by requirements that apply to specialist and other health services, the Health Personnel Act and the Patient Rights Act. Under each of the regional health authorities, there are several health trusts (HF), which can consist of one or more hospitals. A health trust (HF) is wholly owned by an RHF.

Research is one of the four main tasks of hospital trusts.⁴ The three other main tasks are to ensure good treatment, education and training of patients and relatives. Research is important if the health service is to keep abreast of stay up-to-date with medical developments and carry out critical assessments of established and new diagnostic methods,

treatment options and technology, and work on quality development and patient safety while caring for and guiding patients.

The committee is invited to assess the extent to which the research activities and results of each administrative unit have contributed to sectoral purposes as described above. The assessment does not include an evaluation of the health services performed by the services.

2.5 Relevance to society

The committee assesses the quality, scale and relevance of contributions targeting specific economic, social or cultural target groups, of advisory reports on policy, of contributions to public debates, and so on. The documentation provided as the basis for the assessment of societal relevance should make it possible to assess relevance to various sectors of society (i.e. business, the public sector, non-governmental organisations and civil society).

When relevant, the administrative units will be asked to link their contributions to national and international goals set for research, including the Norwegian Long-term Plan for Research and Higher Education and the UN Sustainable Development Goals. Sector-specific objectives, e.g. those described in the Development Agreements for the HEIs and other national guidelines for the different sectors, will be assessed as part of criterion 2.4.

The committee is also invited to assess the societal impact of research based on case studies submitted by the administrative units and/or other relevant data presented to the committee. Academic impact will be assessed as part of criterion 2.2.

3 Evaluation process and organisation

The RCN will organise the assessment process as follows:

- Commission a professional secretariat to support the assessment process in the committees and panels, as well as the production of self-assessments within each RPO
- Commission reports on research personnel and publications within life sciences based on data in national registries
- Appoint one or more evaluation committees for the assessment of administrative units.
- Divide the administrative units between the appointed evaluation committees according to sectoral affiliation and/or other relevant similarities between the units.
- Appoint a number of expert panels for the assessment of research groups submitted by the administrative units.
- Divide research groups between expert panels according to similarity of research subjects or themes.
- Task the chairs of the evaluation committees with producing a national-level report building on the assessments of administrative units and a national-level assessments produced by the expert panels.

Committee members and members of the expert panels will be international, have sufficient competence and be able, as a body, to pass judgement based on all relevant assessment criteria. The RCN will facilitate the connection between the assessment levels of panels and committees by appointing committee members as panel chairs.

3.1 Division of tasks between the committee and panel levels

The expert panels will assess research groups across institutions and sectors, focusing on the first two criteria specified in Chapter 2: 'Strategy, resources and organisation' and 'Research production and quality' The assessments from the expert panels will also be used as part of the evidence base for a report on Norwegian research within life sciences (see section 3.3).




Figure 1. Evaluation committees and expert panels

The evaluation committees will assess the administrative units based on all the criteria specified in Chapter 2. The assessment of research groups delivered by the expert panels will be a part of the evidence base for the committees' assessments of administrative units. See figure 1 below.

The evaluation committee has sole responsibility for the assessments and any recommendations in the report. The evaluation committee reaches a judgement on the research based on the administrative units and research groups' self-assessments provided by the RPOs, any additional documents provided by the RCN, and interviews with representatives of the administrative units. The additional documents will include a standardised analysis of research personnel and publications provided by the RCN.

The evaluation committee takes international trends and developments in science and society into account when forming its judgement. When judging the quality and relevance of the research, the committees shall bear in mind the specific tasks and/or strategic goals that the administrative unit has set for itself including sectoral purposes (see section 2.4 above).

3.2 Accuracy of factual information

The administrative unit under evaluation should be consulted to check the factual information before the final report is delivered to the RCN and the board of the institution hosting the administrative unit.

3.3 National level report

Finally, the RCN will ask the chairs of the evaluation committees to produce a national-level report that builds on the assessments of administrative units and the national-level assessments produced by the expert panels. The committee chairs will present their assessment of Norwegian research in life sciences at the national level in a separate report that pays specific attention to:

- Strengths and weaknesses of the research area in the international context
- The general resource situation regarding funding, personnel and infrastructure
- PhD training, recruitment, mobility and diversity
- Research cooperation nationally and internationally
- Societal impact and the role of research in society, including Open Science

This national-level assessment should be presented to the RCN.

- e) Relevance to society
